Annual General Meeting 27th May 2021 Results

Shareholder Information

- ❖ Shareholders registered on 27th April 2021 were entitled to receive notice of the Annual General Meeting and vote on the resolutions tabled.
- ❖ The Company has only one class of shares and all shares carry equal voting rights.
- ❖ The total number of shares eligible to participate in the meeting was 101,310,488 (the issued share capital).

Voting eligibility for Election of Directors

- ❖ The majority shareholder holds 66,281,050 shares (65.4%).
- ❖ The minority shareholders hold 35,029,438 shares (34.6%).
- ❖ The majority shareholder appoints five directors in terms of the Company’s Memorandum & Articles of Association.

Shares represented at the Meeting

- ❖ Shares represented through Proxy attendance 75,506,779

Voting Results

❖ Ordinary Resolution 1

“That the Annual Report and Financial Statements of the Company for the year ended 31 December 2020, comprising the Financial Statements and the Directors’ and Auditors’ Reports thereon, be hereby received and approved”.

The resolution was approved with a 99.95% vote (75,470,519 votes For 0 votes Against)

❖ Ordinary Resolution 2

“That the Meeting approves the payment of a Net Dividend of €0.16 per share (after taxation) to all Shareholders of GO p.l.c. registered on the Shareholders’ register as at Tuesday 27 April 2021. The payment of this Net Dividend amounts to the sum of €16.21 million”.

The resolution was approved with a 100% vote (75,506,779 votes For 0 votes Against)

❖ Ordinary Resolution 3

“That the reappointment of PricewaterhouseCoopers Certified Public Accountants and Auditors be hereby approved and the Board of Directors be hereby authorised to establish their remuneration”.

The resolution was approved with a 99.94% vote (75,468,642 votes For 1,877 votes Against)

❖ Ordinary Resolution 4

“To establish the maximum and aggregate emoluments of the Directors at €300,000”.

The resolution was approved with a 99.92% vote (75,448,823 votes For 19,496 votes Against)

❖ Ordinary Resolution 5

“To proceed with the election of Directors in accordance with Article 57.2 (b) of the Articles of Association of the Company”.

❖ Ordinary Resolution 6 – Special Business – Advisory Vote
